

How to Apply for Association:

Members

New Agent Members:

- 1. New agent members will complete Membership Application, MARIS Application, MREC consent Form and send to sgarmembership@sgarealtors.org.
- 2. The association will call to set an appointment to meet the new agent member, complete payment of dues and fees, and distribute membership information. New Members will be paying for National, State and Local membership dues and fees.
- 3. New members are required to complete the Introduction to the Code of Ethics and New Member Orientation. New members will need to attend the orientation day within 90 days. There will be 3 opportunities during this time for the new members to attend. The classes are held from 9am to 4 pm, and lunch is provided. Some of the topics new members will learn:
 - REALTOR® Code of Ethics
 - The National, State, and Local Association benefits and activities
 - REALTOR® Safety
 - Missouri Real Estate Commission Continuing Education
 - MARIS Training

Transfer Agent from Brokerage to Brokerage or Sending license back to state.

Association Transfers or Secondary Membership Agents:

- 1. Transfer or Secondary Membership Agents will complete SGAR Application and send to sgarmembership@sgarealtors.org.
- 2. Transfer agents or Secondary Members will need to have a letter of good standing from their association they are currently members. The letter will let SGAR know that they are current with national state, and local dues. The letter will also update SGAR of your national Code of Ethic and Fair Housing Requirement status. Transfer and Secondary Members do not need to complete the New Member Orientation, unless they have completed the New Member Orientation at their initial association.
- 3. Transfer and Secondary Membership dues will consist of dues for local membership and a \$15 transfer fee.
- 4. After membership is updated in the association's system, a membership staff will call the transfer or secondary member to finalize any membership questions, complete dues and fees payment, and answer any questions them member may have.
